Alfred is an Associate Director with M/s Patrick Tan LLC. He specialises in commercial litigation, with a particular emphasis on construction and engineering disputes. Alfred has been involved in litigation at all levels of the Singapore's courts as well as arbitrations. He has appeared in both the Supreme Court and Subordinate Courts for full hearings and interlocutory applications.

Alfred graduated from the National University of Singapore with two degrees. He first obtained a Bachelor of Engineering, Civil (Hons) degree before going on to obtain his Bachelor of Laws (Hons) degree, which he completed under the Graduate Law Programme.

Alfred was a prosecutor with the Ministry of Manpower for more than 4 years. Whilst at MOM, Alfred led and trained a team of prosecutors in the enforcement of the Factories Act (now Workplace Safety and Health Act). He also assisted in the drafting of the Workplace Safety and Health Act and its subsidiary legislation. Alfred represented the Ministry in the Subordinate Courts in the enforcement of various statutes that were administered by the MOM. He also served a stint at the Attorney-General's Chambers as an Assistant Public Prosecutor where he dealt with various Penal Code offences.

In private practice, Alfred completed his pupillage with a Senior Counsel and commenced his practice in the litigation and dispute resolution department of one of the leading law firms in Singapore. In 2011, Alfred authored the chapter on contract law in the 4th edition of "You and the Law", a legal guide published by the Singapore Association of Women Lawyers.
