Membership of the Medical Program Board's Clinical Advisory Group

The College of Medicine and Public Health, Flinders University is seeking to fill positions on the Medical Program's Clinical Advisory Group.

We are calling for an expression of interest from clinicians who are genuinely committed to the delivery of high-quality outcomes in the Doctor of Medicine (MD) program.

The Clinical Advisory group will report to the Medical Program Board. The Medical Program Board is the peak decision making and policy setting body of the Medical Program. and has a membership with clear accountability for specific portfolios relating to the Medical Program. The Head of the Medical Program takes strategic direction from the Board. The Board seeks papers and views on policy matters from Medical Program Leadership, Topic Coordinators, Portfolio Advisors, Clinical Advisory Group and professional staff and students, as appropriate. The Medical Program Board facilitates communication and widespread collaboration amongst its members and stakeholders to ensure clarity of roles and responsibilities throughout the medical education chain.

Role of the Clinical Advisory Group

The role of the Clinical Advisory Group is to provide advice to the Medical Program Board in relation to the delivery of the Doctor of Medicine Program, in line with Australian Medical Council Standards. Input is sought from a wide range of practicing clinicians across the College of Medicine and Public Health's footprint, including all disciplines, levels of experience and geographical locations. Members of the group will be accountable to the Clinical Advisory Group and to the Medical Program Board. Tenure will be up to a period of three years.

Role of the member

The role of members is to:

- Work closely with the Medical Program Board and MD program staff to ensure high standards of student satisfaction with teaching and intern readiness
- Reflect on how clinical teaching is delivered and evaluated within the MD and provide advice to the Board based on best evidence for clinical education
- Develop and support improvement initiatives and guide resolution of issues
- Encourage and support clinician engagement with Flinders University
- Adhere to university policies, procedures and processes
- Actively support and promote the relationship between clinicians and Flinders University, including the Academic Status Program
- Engage with student leadership and MD Leadership in the co-creation and development of any new initiatives

Who are we seeking?

We are seeking a broad range of clinical backgrounds, experience and focus and seek applications from clinicians who are:

- Focused on the student experience
- Able to work positively and collaboratively to overcome issues and challenges
- Working across Flinders University's footprint, including PRCC, Alice Springs, Nhulunbuy and Darwin
- General Practitioners and other Specialists working and teaching in all clinical teaching environments including Hospitals and Community in Metropolitan, Rural and Remote areas

Structure and time commitment for meetings

Clinical Advisory Group meetings will be held every month for approximately one hour, via Microsoft Teams. In addition, the Group may seek broader input via open fora when required.
